Note: Six of the above-listed OSI subjects have been prosecuted abroad on criminal charges following their removal from the United States: Feodor Fedorenko (convicted in the U.S.S.R. in 1986 and executed); Karl Linnas (died in prison in Estonia in 1987 while awaiting trial); John (Ivan) Demjanjuk (convicted and sentenced to death in Israel in 1988; conviction reversed and defendant returned to United States in 1993); Boleslavs Maikovskis (trial in Muenster, Germany terminated in 1994 due to defendant's poor health); Bruno Karl Blach (indicted in 1990 in West Germany; acquitted in Duisberg 3/25/93); and Andrija Artukovic (convicted in 1986 in Zagreb, (then) Croatian Republic of Yugoslavia; died in prison in 1988 while his petition for commutation of death sentence was pending).
